1. **Accommodation:** Good-quality hotels / \*\*\*\*\* & \*\*\* hotels / Mexico Standard (the tour is based on 2 participants sharing a hotel room; please contact us for single or triple rooms)
2. **Luggage:**  
1 piece of checked luggage (suitcase or bag) and 1 piece of carry-on luggage (backpack) for bus trips. Please note that you must purchase luggage insurance, as we are not responsible for your luggage. (Please attach a copy.) The owner is responsible for their luggage in all cases.
3. **Cancellation and Refund:**  
All cancellations must be submitted in writing to the address we provide. The following cancellation fees apply to all tours: a non-refundable deposit of €700. The remaining balance is due by August 16, 2026. After August 20, 2026, no refunds will be issued for any reason. Your deposit and any payments made are non-transferable. When I take people on an international trip, comprehensive travel and cancellation insurance is a prerequisite.
4. **Responsibility:**  
Pranalight and Carolina Hehenkamp, Onenesstravel, RMCTRAVEL, and their Mexican and American agents act solely as intermediaries for passengers in all matters related to accommodations, sightseeing tours, and transportation, whether by plane, train, cruise ship, bus, or other means of transportation, they are not responsible or liable for injuries, losses, accidents, delays, irregularities, or incidents attributable to strikes, weather, government regulations, acts of war, or force majeure;  
Nor are they responsible for damage to or loss of luggage during the trip, or for acts or omissions of individuals or organizations providing transportation, services, or accommodations in connection with these arrangements, or for delays or costs resulting from interruptions or changes to the schedule, or for causes beyond their own control.  
We reserve the right to cancel a tour, refuse or withhold a person as a member of the tour, or make changes to the published itinerary if circumstances warrant it or if we deem it necessary for the comfort, convenience, or safety of the passengers.  
We have the right, at any time and at our sole discretion, to cancel a trip or the remainder of a trip, or to make changes to the route, accommodations, price, or other details, if a trip becomes impossible, illegal, or inadvisable due to weather, avalanches, strikes, war, government intervention, orders, or other reasons. All additional costs incurred as a result shall be your responsibility. All prices are based on the rates and exchange rates applicable in May 2026 in U.S. dollars and are subject to change in the event of an adjustment. Should costs fluctuate due to circumstances beyond our control, we reserve the right to change the price we offer.
